# VILLAGE OF MOUNT MORRIS RESOLUTION TO SCHEDULE PUBLIC HEARING AND MAKE 239(M) REFERRAL TO COUNTY PLANNING BOARD REGARDING LOCAL LAW NO. A OF 2025 ENTITLED

"ESTABLISHING A TEMPORARY LAND USE MORATORIUM PROHIBITING THE ESTABLISHMENT OF TOBACCO STORES WITHIN THE VILLAGE OF MOUNT MORRIS"

Adopted: July 8, 2025

The Village Board of the Village of Mount Morris met at a regular board meeting at the Village Offices of the Village of Mount Morris located at 117 Main Street, Mount Morris, New York on the 8<sup>th</sup> day of July, 2025, commencing at 6:30 P.M., at which time and place the following members were:

WHEREAS, all Board Members, having due notice of said meeting, and that pursuant to Article 7, §104 of the Public Officers Law, said meeting was open to the general public and due and proper notice of the time and place whereof was given as required by law; and

WHEREAS, tobacco stores are currently a permitted principle use pursuant to the Village Code in the Village's B-1 Local Business District (§ 232-18(A)(14)) and in the B-2 Central Business District (§ 232-19(A)(r)); and

**WHEREAS,** the Village has recently become aware of the increasing frequency of violations of the Adolescent Tobacco Use Prevention Act by tobacco and smoke shops both locally in Livingston County, and across New York State: and

WHEREAS, the Village has also recently become aware of the increasing frequency of tobacco and smoke shops engaging in the unauthorized and/or illegal sale of cannabis products, and the increasing frequency at which tobacco and smoke shops are being targeted in robberies and burglaries; and

WHEREAS, in order to protect health, safety, and welfare of the Village's residents, and the general character of the Village community, the Village Board wishes to enact a temporary land use moratorium to prohibit the establishment of any new tobacco stores within the Village while the Village Board works to revise the provisions of the Village Code which govern the establishment and operation of tobacco stores and smoke shops; and

WHEREAS, the Village Board of the Village of Mount Morris has considered a proposed local law drafted by the Village's Attorney entitled "Establishing a Temporary Land Use Moratorium Prohibiting the Establishment of Tobacco Stores within the Village of Mount Morris," to temporarily halt the establishment of new tobacco stores for a period of up to six (6) months, while the Village considers comprehensive zoning changes and the enactment of zoning measures to specifically address the establishment and operation of tobacco stores within the Village; and

WHEREAS, pursuant to Section 239-M of the General Municipal Law, said local law with all supporting documents must be submitted to the Livingston County Planning Board for its comments prior to adoption; and

WHEREAS, the Village Board of the Village of Mount Morris recognizes that this local law is a Type II Action pursuant to 6 NYCRR § 617.5(c)(36), and therefore SEQR review will not be required as there are no adverse environmental impacts; and

**WHEREAS**, the Village Board of the Village of Mount Morris finds it to be in the best interest of the Village of Mount Morris to hold a public hearing on the adoption of said local law; and

NOW ON MOTION OF Trustee Bryant which has been duly seconded by Trustee Torcello, be it

**RESOLVED,** by the Village Board of the Village of Mount Morris that a public hearing shall be held on the proposed local law on the 12<sup>th</sup> day of August 2025, at 6:30 P.M., at which time and place all interested parties and citizens for or against the proposed law will be heard; and be it further

**RESOLVED,** that the proposed local law and all supporting documents shall be submitted to the Livingston County Planning Board for comments and recommendations in accordance with Section 239-M of the General Municipal Law.
