RESOLUTION TO EXECUTE LEASE TERMINATION

REGARDING LEASE OF MOUNT MORRIS YOUTH CENTER

The Village Board of the Village of Mount Morris met at a regular board meeting at the Village Offices of the Village of Mount Morris located at 117 Main Street, Mount Morris, New York on the 25th day of November, 2025, commencing at ____ P.M., at which time and place the following members were:

WHEREAS, all Board Members, having due notice of said meeting, and that pursuant to Article 7, §104 of the Public Officers Law, said meeting was open to the general public and due and proper notice of the time and place whereof was given as required by law; and

WHEREAS, on or about November 1, 2024, the Village of Mount Morris (the “Village”) entered into a lease (the “Lease”) with Joshua D. Bacon and Kelly D. Bacon (“Tenants”) regarding the property commonly known as the Mount Morris Youth Center (the “Property”) (a copy of such lease is attached hereto as ***Schedule 1***) as authorized pursuant to Village Law § 1-102(1); and

WHEREAS, the Lease had a lease term of November 1, 2024 to October 31, 2026; and

WHEREAS, the Village and Tenants now wish to terminate the lease and return possession of the property to the Village; and

WHEREAS, the Village Board believes it to be in the public interest to terminate the lease and return the possession of the property to the Village; and

WHEREAS, the Village Attorney has prepared a draft agreement to terminate the lease (the “Termination Agreement”) which has been provided to and reviewed by the Village Board (a copy of such agreement is attached hereto as ***Schedule 2***); and

WHEREAS, the Village Board has determined that the Deputy Mayor is the appropriate Village Board Member to execute the Termination Agreement on behalf of the Village; and

WHEREAS, the Village Board now wishes to authorize the Deputy Mayor to execute the Termination Agreement on behalf of the Village; and

NOW ON MOTION OF Trustee Richardson which has been duly seconded by Trustee Shea, be it

RESOLVED, by the Village Board of the Village of Mount Morris that it is in the best interest of the Village to terminate the lease agreement; and be it further

RESOLVED, that the Village Board hereby authorizes and directs the Deputy Mayor of the Village of Mount Morris to execute the Termination Agreement on behalf of the Village.

Resolved that in order to provide appropriate deterrence and a revised fine structure for second and subsequent offenses, village board will pursue amending local law chapter 59 article 3 section 59-15 “penalties for offenses” of the Village of Mount Morris code with a fine structure of \$50-\$100 for first offense, \$100-\$200 for second offense, and \$200-\$300 for a third offense.

Board discussed closing sections of State Street and Federal Street for the upcoming Christmas Magic in Mount Morris and agreed to block off those sections. Superintendent Young will provide cones and PD is aware of the closings.

Tracy Kenney asked about steps for unpaid water, asked if there's another youth center in village

Gretchen Saunders asked about the grant services at the county, asked about grant classes, a property on Hopkins St where trash is reported, asked about dog laws, asked about emails and phone numbers on website, asked when salt shed plans started, and asked when the last audit was

Tracy Kenney asked about the water treatment plant, asked about attorney fees, asked if the village has hired for dpw positions

Randy Johnson asked when the body cameras will be installed for officers, and Chief Wilcox answered "as soon as possible" and gave additional information regarding the technical work that is being done to get them operational.

Tracy Kenney asked about Clerk Torcello's training

Joshua Bacon commented on the dog seizure process

Tracy Kenney asked if employees are multi-trained

Mayor Bacon announced the next board meeting is December 9th.
